The Jim Luce Memorial Scholarship Application Guidelines

(Scholarship administered by the Texas Towing and Storage Association)

Criteria:

Scholarships will be awarded to TTSA members in good standing, or employees of TTSA members in good standing, or parent, spouses, children, grandchildren of TTSA members only.

Eligible candidates must complete the following requirements:

- Graduating High School Seniors must achieve a minimum score of 800 on the SAT or 18 on the ACT.
- Graduating High School Seniors must submit an official high school transcript.
- College sophomores through seniors must provide a transcript indicating the number of hours completed.
- Attending or planning to attend a school which is accredited by the Southern Association of Colleges and Universities or its equivalent.
- Submission of a written essay stating the reason for application and goals of the candidate.
- Submission of two letters of recommendation from non-family members.
- Submission of photo (the winner's photo will be published on the TTSA website)

To apply for a Jim Luce Memorial Scholarship:

- Complete the scholarship application form and provide all information requested in the application requirements.
- Absence of any required items will render your application incomplete.
- The application is valid ONLY for current academic year. You must reapply annually.

The amount of the Scholarship maybe up to \$500.00 based on Scholarship Fund

The deadline for application submission must be postmarked by April 26, 2020
